Clubhouse Works

"Our belief is that members want opportunities to discover fulfillment and inclusivity through the world of work. In 2013 at the Clubhouse's 17th International Seminar in Saint Louis, there was a plenary presentation entitled *Employment: The Ace in The Clubhouse Recovery Deck* by Mark Maragno, Director of Charles Webster Potter Place in Waltham Mass. In this article, Lee Elliott spoke about the belief that employment is "the key cornerstone needed by all Clubhouses". Village Clubhouse mirrors this belief and continues to dedicate our efforts to support members on their paths of recovery through employment.

Since opening our doors in December of 2018, the Clubhouse has supported more than 65 members access Transitional or Supported/ Independent Employment opportunities with a variety of different employers. In the process of writing this article, I recall the excitement and enthusiasm shared about the Clubhouse Model from community members, providers and perspective members about the various degree of employment supports and opportunities available. This information was somewhat foreign to so many of our founding members. It quickly became evident that the key to our success hinged on rapid development of our employment program. This targeted approach continues to play a significant role in our daily decisions. As we develop and target specific employers in our community, with the intentional goal of diversifying employment opportunities to assist our membership move from part-time employment to fulltime employment. We believe we are one step closer to fighting the stigma of mental illness and leading our members out of survival jobs to sustainable careers." In 2021 members of Village Clubhouse earned \$252,246.30 through paid employment.



Clubhouse Employment Definitions

Transitional Employment (TE)- The Clubhouse places members in parttime jobs at local employers and provides full on- and- off site support, transportation, and absentee coverage. Supported Employment (SE)- The Clubhouse supports an employed member and their employer through regular contact and on-site visits. Independent Employment (IE)- The Clubhouse helps members transition to full-time employment in jobs of their own.

Kevin Jones has been working with Old Navy for more than

22 years in different capacities. He grew through the company, becoming a General Manager in 2005. He first became familiar with the Clubhouse Model when he was approached by Capitol Clubhouse staff in 2010 and a partnership quickly ensued. This partnership between Capitol Clubhouse and Old Navy continues to this day. When Kevin relocated to Bangor in 2012, he had the opportunity to continue his relationship with Clubhouse by partnering with Unlimited Solutions Clubhouse by providing Transitional and Supported Employment opportunities to the membership. Kevin was also briefly on their Advisory Board prior to relocating to Freeport. Upon learning about the opening of Village Clubhouse in Topsham in 2018, Kevin once again was pleased to partner with the Clubhouse by offering two Transitional Employment Placements to Village Clubhouse. This partnership was vital to the early growth and development of Village Clubhouse as it enabled Village to immediately offer employment opportunities to its new and growing membership. When Candy Lessard, Director of Village Clubhouse, began to assemble the Advisory Board it was obvious that Kevin was high on the list of prospective Board members. Kevin accepted this invitation, and continues to promote the Clubhouse model within his role. Through his work with the Clubhouse, Kevin has provided well over 100 members an opportunity for paid employment and that number continues to grow. His support of the Clubhouse model throughout the years has been a launching point for member's employment, independence and overall recovery. We are proud to recognize Kevin this year for the James R. Schmidt award for his continuous dedication, passion, and commitment to the Clubhouse Model of Rehabilitation.
